
- Neural networks: Nonlinear generalization of GLMs
 - Here, defined by a logistic regression model applied to a logistic regression model

$$p(y|\mathbf{x}, \boldsymbol{\theta}) = \text{Ber}\left(y|\text{sigm}\left(\mathbf{w}^T \text{sigm}(\mathbf{V}\mathbf{x})\right)\right)$$

 To make the connection b/w GP and NN [Neal 96], now consider a neural network for regression with one hidden layer

$$p(y|\mathbf{x}, \boldsymbol{\theta}) = \mathcal{N}(y|f(\mathbf{x}; \boldsymbol{\theta}), \sigma^2)$$

$$f(\mathbf{x}) = b + \sum_{j=1}^{H} v_j g(\mathbf{x}; \mathbf{u}_j)$$



Use the priors on the weights:

$$\boldsymbol{\theta} \left\{ \begin{array}{l} b \sim \mathcal{N}(0, \sigma_b^2) \\ \mathbf{v} \sim \prod_j \mathcal{N}(v_j | 0, \sigma_w^2) \\ \mathbf{u} \sim \prod_j p(\mathbf{u}_j) \end{array} \right.$$

$$\mathbb{E}_{\boldsymbol{\theta}} [f(\mathbf{x})] = 0$$

$$\mathbb{E}_{\boldsymbol{\theta}} [f(\mathbf{x})f(\mathbf{x}')] = \sigma_b^2 + \sum_j \sigma_v^2 \mathbb{E}_{\mathbf{v}} [g(\mathbf{x}; \mathbf{u}_j)g(\mathbf{x}'; \mathbf{u}_j)]$$

$$= \sigma_b^2 + H\sigma_v^2 \mathbb{E}_{\mathbf{u}} [g(\mathbf{x}; \mathbf{u})g(\mathbf{x}'; \mathbf{u})]$$

- Let σ_v^2 as ω^2/H
 - since more hidden units will increase the input to the final node, so we should scale down the magnitude of the weights

$$\mathbb{E}_{\boldsymbol{\theta}} \left[f(\mathbf{x}) f(\mathbf{x}') \right] = \sigma_b^2 + \omega^2 \mathbb{E}_{\mathbf{u}} \left[g(\mathbf{x}; \mathbf{u}) g(\mathbf{x}'; \mathbf{u}) \right]$$



If we use as activation / transfer function

$$g(\mathbf{x}; \mathbf{u}) = \operatorname{erf}(u_0 + \sum_{j=1}^{D} u_j x_j)$$
 $\operatorname{erf}(z) = 2/\sqrt{\pi} \int_0^z e^{-t^2} dt$
and choose $\mathbf{u} \sim \mathcal{N}(\mathbf{0}, \mathbf{\Sigma})$

• Then the covariance kernel [William '98]:

$$\kappa_{NN}(\mathbf{x}, \mathbf{x}') = \frac{2}{\pi} \sin^{-1} \left(\frac{2\tilde{\mathbf{x}}^T \mathbf{\Sigma} \tilde{\mathbf{x}}'}{\sqrt{(1 + 2\tilde{\mathbf{x}}^T \mathbf{\Sigma} \tilde{\mathbf{x}})(1 + 2(\tilde{\mathbf{x}}')^T \mathbf{\Sigma} \tilde{\mathbf{x}}')}} \right)$$

This is a true "neural network" kernel

Feedforward neural networks

NN with two layers for a regression problem

$$p(y|\mathbf{x}, \boldsymbol{\theta}) = \mathcal{N}(y|\mathbf{w}^T\mathbf{z}(\mathbf{x}), \sigma^2)$$
$$\mathbf{z}(\mathbf{x}) = g(\mathbf{V}\mathbf{x}) = [g(\mathbf{v}_1^T\mathbf{x}), \dots, g(\mathbf{v}_H^T\mathbf{x})]$$

- g: a non-linear activation or transfer function
- $-z(x) = \phi(x, V)$: called the **hidden layer**
- NN for binary classification

$$p(y|\mathbf{x}, \boldsymbol{\theta}) = \text{Ber}(y|\text{sigm}(\mathbf{w}^T\mathbf{z}(\mathbf{x})))$$

NN for multi-output regression


$$p(\mathbf{y}|\mathbf{x}, \boldsymbol{\theta}) = \mathcal{N}(\mathbf{y}|\mathbf{W} \ \boldsymbol{\phi}(\mathbf{x}, \mathbf{V}), \sigma^2 \mathbf{I})$$

NN for multi-class classification

$$p(y|\mathbf{x}, \boldsymbol{\theta}) = \text{Cat}(y|\mathcal{S}(\mathbf{W}\mathbf{z}(\mathbf{x})))$$

Feedforward neural networks

$$p(\mathbf{y}|\mathbf{x}, \boldsymbol{\theta}) = \mathcal{N}(\mathbf{y}|\mathbf{W}|\boldsymbol{\phi}(\mathbf{x}, \mathbf{V}), \sigma^2 \mathbf{I})$$



A neural network with one hidden layer.

Use prior of the form:

$$p(\mathbf{w}) = \mathcal{N}(\mathbf{w}|\mathbf{0}, (1/\alpha)\mathbf{I})$$

- where w represents all the weights combined
- Posterior can be approximated:

$$p(\mathbf{w}|\mathcal{D}, \alpha, \beta) \propto \exp(-E(\mathbf{w}))$$

$$E(\mathbf{w}) \triangleq \beta E_D(\mathbf{w}) + \alpha E_W(\mathbf{w})$$

$$E_D(\mathbf{w}) \triangleq \frac{1}{2} \sum_{n=1}^{N} (y_n - f(\mathbf{x}_n, \mathbf{w}))^2$$

$$E_W(\mathbf{w}) \triangleq \frac{1}{2} \mathbf{w}^T \mathbf{w}$$

• A second-order Taylor series approximation of $E(\mathbf{w})$ around its minimum (the MAP)

$$E(\mathbf{w}) \approx E(\mathbf{w}_{MP}) + \frac{1}{2}(\mathbf{w} - \mathbf{w}_{MP})^T \mathbf{A}(\mathbf{w} - \mathbf{w}_{MP})$$

A is the Hessian of E

$$\mathbf{A} = \nabla \nabla E(\mathbf{w}_{MP}) = \beta \mathbf{H} + \alpha \mathbf{I}$$
$$\mathbf{H} = \nabla \nabla E_D(\mathbf{w}_{MP})$$

 Using the quadratic approximation, the posterior becomes Gaussian:

$$p(\mathbf{w}|\alpha,\beta,\mathcal{D}) \approx \mathcal{N}(\mathbf{w}|\mathbf{w}_{MP},\mathbf{A}^{-1})$$

- Parameter posterior for classification
 - The same as the regression case, except $\beta=1$ and E_D is a cross entropy error of the form

$$E_D(\mathbf{w}) \triangleq \sum_{n=1}^{N} [y_n \ln f(\mathbf{x}_n, \mathbf{w}) + (1 - y_n) \ln f(\mathbf{x}_n, \mathbf{w})]$$

Predictive posterior for regression

$$p(y|\mathbf{x}, \mathcal{D}, \alpha, \beta) = \int \mathcal{N}(y|f(\mathbf{x}, \mathbf{w}), 1/\beta) \mathcal{N}(\mathbf{w}|\mathbf{w}_{MP}, \mathbf{A}^{-1}) d\mathbf{w}$$

- The posterior predictive density is not analytically tractable because of the nonlinearity of f(x, w)
- Let us construct a first-order Taylor series approximation around the mode:

$$f(\mathbf{x}, \mathbf{w}) \approx f(\mathbf{x}, \mathbf{w}_{MP}) + \mathbf{g}^{T}(\mathbf{w} - \mathbf{w}_{MP})$$
$$\mathbf{g} = \nabla_{\mathbf{w}} f(\mathbf{x}, \mathbf{w})|_{\mathbf{w} = \mathbf{w}_{MP}}$$

- Predictive posterior for regression
 - We now have a linear-Gaussian model with a Gaussian prior on the weights

$$-p(y|\mathbf{x}, \mathcal{D}, \alpha, \beta) \approx \mathcal{N}(y|f(\mathbf{x}, \mathbf{w}_{MP}), \sigma^2(\mathbf{x}))$$


– The predictive variance depends on the input x:

$$\sigma^2(\mathbf{x}) = \beta^{-1} + \mathbf{g}^T \mathbf{A}^{-1} \mathbf{g}$$

- The posterior predictive density for an MLP with 3 hidden nodes, trained on 16 data points
 - The dashed green line: the true function
 - The solid red line: the posterior mean prediction


Result of using a Laplace approximation after performing empirical Bayes to optimize the hyperparameters

the dotted blue line: 1 standard deviation



Result of using hybrid Monte Carlo, using the same trained hyperparameters as in (a)

the dotted blue lines are samples from



- Predictive posterior for classification
 - Approximate p(y|x,D) in the case of binary classification
 - The situation is similar to the case of logistic regression, except in addition the posterior predictive mean is a nonlinear function of w

$$\mu = \mathbb{E}[y|\mathbf{x}, \mathbf{w}] = \text{sigm}(a(\mathbf{x}, \mathbf{w}))$$

• where a(x, w) is the pre-synaptic output of the final layer

$$a(\mathbf{x}, \mathbf{w}) \approx a_{MP}(\mathbf{x}) + \mathbf{g}^{T}(\mathbf{w} - \mathbf{w}_{MP})$$
$$a_{MP}(\mathbf{x}) = a(\mathbf{x}, \mathbf{w}_{MP})$$
$$\mathbf{g} = \nabla_{\mathbf{x}} a(\mathbf{x}, \mathbf{w}_{MP})$$

Predictive posterior for classification

$$p(a|\mathbf{x}, \mathcal{D}) \approx \mathcal{N}(a(\mathbf{x}, \mathbf{w}_{MP}), \mathbf{g}(\mathbf{x})^T \mathbf{A}^{-1} \mathbf{g}(\mathbf{x}))$$

- The posterior predictive for the output

$$p(y = 1 | \mathbf{x}, \mathcal{D}) = \int \operatorname{sigm}(a) p(a | \mathbf{x}, \mathcal{D}) da \approx \operatorname{sigm}(\kappa(\sigma^2) \ a_{MP}(\mathbf{x}))$$
$$\kappa(\sigma^2) \quad \triangleq \quad (1 + \pi \sigma^2 / 8)^{-\frac{1}{2}}$$

Using the approximation

$$\int \operatorname{sigm}(a) \mathcal{N}(a|\mu, \sigma^2) da \approx \operatorname{sigm}(\kappa(\sigma^2)\mu)$$
$$\kappa(\sigma^2) \triangleq (1 + \pi \sigma^2/8)^{-\frac{1}{2}}$$

- The statement
 - A neural network with arbitrary depth and nonlinearities, with dropout applied before every weight layer is mathematically equivalent to an approximation to the probabilistic deep Gaussian process (Damianou & Lawrence, 2013)
- The notations
 - $-\widehat{\mathbf{y}}$: the output of a NN model with L layers and a loss tunction $E(\cdot,\cdot)$ such as the softmax loss or the Euclidean loss (square loss)
 - $-\mathbf{W}_i \in R^{K_i \times K_{i-1}}$: NN's weight matrix at i-th layer
 - $-\mathbf{b}_{i}$: the bias vector at i-th layer

L2 regularisation of NN

$$\mathcal{L}_{\text{dropout}} := \frac{1}{N} \sum_{i=1}^{N} E(\mathbf{y}_i, \widehat{\mathbf{y}}_i) + \lambda \sum_{i=1}^{L} \left(||\mathbf{W}_i||_2^2 + ||\mathbf{b}_i||_2^2 \right)$$

- The deep Gaussian process
 - assume we are given a covariance function of the form

$$\mathbf{K}(\mathbf{x}, \mathbf{y}) = \int p(\mathbf{w})p(b)\sigma(\mathbf{w}^T\mathbf{x} + b)\sigma(\mathbf{w}^T\mathbf{y} + b)d\mathbf{w}db$$

– a deep GP with L layers and covariance function $K(\boldsymbol{x},\boldsymbol{y})$ can be approximated by placing a variational distribution over each component of a spectral decomposition of the GPs' covariance functions

Dropout as a Bayesian Approximation

• Now, \mathbf{W}_i is a random matrix of dims $K_i \times K_{i-1}$ where each row of $\mathbf{W}_i \sim p(\mathbf{w})$

$$\boldsymbol{\omega} = \{\mathbf{W}_i\}_{i=1}^L$$

 \mathbf{m}_i of dims K_i for each GP layer

The predictive probability of the deep GP

$$p(\mathbf{y}|\mathbf{x}, \mathbf{X}, \mathbf{Y}) = \int p(\mathbf{y}|\mathbf{x}, \boldsymbol{\omega}) p(\boldsymbol{\omega}|\mathbf{X}, \mathbf{Y}) d\boldsymbol{\omega}$$

$$p(\mathbf{y}|\mathbf{x}, \boldsymbol{\omega}) = \mathcal{N}(\mathbf{y}; \widehat{\mathbf{y}}(\mathbf{x}, \boldsymbol{\omega}), \tau^{-1} \mathbf{I}_{D})$$

$$\widehat{\mathbf{y}}(\mathbf{x}, \boldsymbol{\omega} = \{\mathbf{W}_{1}, ..., \mathbf{W}_{L}\})$$

$$= \sqrt{\frac{1}{K_{L}}} \mathbf{W}_{L} \sigma \left(... \sqrt{\frac{1}{K_{1}}} \mathbf{W}_{2} \sigma (\mathbf{W}_{1} \mathbf{x} + \mathbf{m}_{1}) ... \right)$$

 $p(\boldsymbol{\omega}|\mathbf{X},\mathbf{Y})$ is intractable

• To approximate $p(\boldsymbol{\omega}|\mathbf{X},\mathbf{Y})$ we define $q(\boldsymbol{\omega})$

$$\mathbf{W}_i = \mathbf{M}_i \cdot \operatorname{diag}([\mathbf{z}_{i,j}]_{j=1}^{K_i})$$

$$\mathbf{z}_{i,j} \sim \operatorname{Bernoulli}(p_i) \text{ for } i = 1, ..., L, \ j = 1, ..., K_{i-1}$$

 Minimise the KL divergence between the approximate posterior and the posterior of the full deep GP

$$-\int q(\boldsymbol{\omega})\log p(\mathbf{Y}|\mathbf{X},\boldsymbol{\omega})\mathrm{d}\boldsymbol{\omega} + \mathrm{KL}(q(\boldsymbol{\omega})||p(\boldsymbol{\omega}))$$

$$\begin{aligned} \mathbf{W}_i &= \mathbf{M}_i \cdot \text{diag}([\mathbf{z}_{i,j}]_{j=1}^{K_i}) \\ \mathbf{z}_{i,j} &\sim \text{Bernoulli}(p_i) \text{ for } i=1,...,L, \ j=1,...,K_{i-1} \end{aligned}$$

$$\boldsymbol{W}_{i} \quad \bigcirc \bigcirc \bigcirc \bigcirc \bigcirc$$

$$\boldsymbol{Z}_{i,1} \quad \boldsymbol{Z}_{i,2} \quad \boldsymbol{Z}_{i,3} \quad \boldsymbol{Z}_{i,K_{i-1}-1} \quad \boldsymbol{Z}_{i,K_{i-1}-1}$$

$$\bigcirc \bigcirc \bigcirc \bigcirc \bigcirc \qquad \bigcirc \bigcirc \bigcirc$$

$$\boldsymbol{M}_{i} \quad diag([\boldsymbol{z}_{i,j}])$$

$$\boldsymbol{W}_{i} = \begin{bmatrix} 1 & & & & & & & & \\ & & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & \\ & & & & & \\ & & & & & \\ & & & & & \\ & & & & & \\ & & & & & \\ & & & & & \\ & & & & \\ & & & & \\ & & & & \\ & & & & \\ & & & & \\ & & \\ & & & \\$$

- Approximate the first team of KL using a single sample $\widehat{\boldsymbol{\omega}}_n \sim q(\boldsymbol{\omega}) : -\log p(\mathbf{y}_n|\mathbf{x}_n,\widehat{\boldsymbol{\omega}}_n)$
- Approximate the second term of KL to:

$$\sum_{i=1}^{L} \left(\frac{p_i l^2}{2} ||\mathbf{M}_i||_2^2 + \frac{l^2}{2} ||\mathbf{m}_i||_2^2 \right)$$

Thus, the approximated KL objective:

$$\mathcal{L}_{\text{GP-MC}} \propto \frac{1}{N} \sum_{n=1}^{N} \frac{-\log p(\mathbf{y}_n | \mathbf{x}_n, \widehat{\boldsymbol{\omega}}_n)}{\tau} + \sum_{i=1}^{L} \left(\frac{p_i l^2}{2\tau N} ||\mathbf{M}_i||_2^2 + \frac{l^2}{2\tau N} ||\mathbf{m}_i||_2^2 \right)$$

Approximate predictive distribution

$$q(\mathbf{y}^*|\mathbf{x}^*) = \int p(\mathbf{y}^*|\mathbf{x}^*, \boldsymbol{\omega}) q(\boldsymbol{\omega}) d\boldsymbol{\omega}$$

- MC dropout for approximation
 - Sample T sets of vectors of realisations from the Bernoulli distribution $\{\mathbf{z}_1^t,...,\mathbf{z}_L^t\}_{t=1}^T$

$$\mathbb{E}_{q(\mathbf{y}^*|\mathbf{x}^*)}(\mathbf{y}^*) \approx \frac{1}{T} \sum_{t=1}^{T} \widehat{\mathbf{y}}^*(\mathbf{x}^*, \mathbf{W}_1^t, ..., \mathbf{W}_L^t)$$

 Model uncertainty (estimating the second raw moment)


$$\mathbb{E}_{q(\mathbf{y}^*|\mathbf{x}^*)}((\mathbf{y}^*)^T(\mathbf{y}^*)) \approx \tau^{-1}\mathbf{I}_D$$

$$+ \frac{1}{T} \sum_{t=1}^T \widehat{\mathbf{y}}^*(\mathbf{x}^*, \mathbf{W}_1^t, ..., \mathbf{W}_L^t)^T \widehat{\mathbf{y}}^*(\mathbf{x}^*, \mathbf{W}_1^t, ..., \mathbf{W}_L^t)$$

$$\operatorname{Var}_{q(\mathbf{y}^*|\mathbf{x}^*)}(\mathbf{y}^*) \approx \tau^{-1} \mathbf{I}_{D}$$


$$+ \frac{1}{T} \sum_{t=1}^{T} \widehat{\mathbf{y}}^*(\mathbf{x}^*, \mathbf{W}_{1}^{t}, ..., \mathbf{W}_{L}^{t})^{T} \widehat{\mathbf{y}}^*(\mathbf{x}^*, \mathbf{W}_{1}^{t}, ..., \mathbf{W}_{L}^{t})$$

$$- \mathbb{E}_{q(\mathbf{y}^*|\mathbf{x}^*)}(\mathbf{y}^*)^{T} \mathbb{E}_{q(\mathbf{y}^*|\mathbf{x}^*)}(\mathbf{y}^*)$$
