

#### Computational Graph for General Backprop


- Node: Indicates a variable
  - Scalar, vector, matrix, and tensor
- Edge: a directed edge from x to y means that y is computed from x (i.e., y=f(x))

- Symbol-to-symbol approach
  - Provide a computational graph for computing derivatives, given original graph
  - Libraries: Theano and TensorFlow

- C.f.) Symbol-to-number approach
  - When numerical values are provided for input on computational graph, it returns numerical values for the gradient
  - Libraries: Torch and Caffe




- Basic subroutines for each variable V
  - get\_operation(V): returns operation that computes V,
     represented by the edges into V
  - get\_consumers(V,G): returns the list of variables that are parents of V in G
  - get\_inputs(V,G): returns the list of variables that are children of V in G

mul

- Each operation op is associated with bprop operation
  - E.g.)  $\boldsymbol{C} = \boldsymbol{A}\boldsymbol{B}$ 
    - D: the gradient with respect to C
    - op.bprop(A)  $\rightarrow DB^T$
    - op.bprop $(B) \rightarrow A^T D$

op.bprop(inputs,X,D)  
=
$$\sum_{i} (\nabla_{X} \text{ op.f(inputs)}_{i})D_{i}$$

- Inputs: a list of inputs to the operation op
- X: the input whose gradient we compute
- **D**: the gradient on the output of the operations
