Randomized Algorithm

- Las Vegas algorithm
 - Always return precisely the correct answer (or report that they failed)
 - Consume a random amount of resources, usually memory or time
 - E.g.) Randomized quicksort
 - The pivot is chosen randomly
- Monte Carlo algorithm
 - Return answers with a random amount of error
 - The amount of error can typically be reduced by expending more resources
 - Provide an approximate answer

Why Sampling?

- Provides a flexible way to approximate many sums and integrals at reduced cost
- Provide a significant speedup to a costly but tractable sum, as in the case when we subsample the full training cost with minibatches
- Approximate an intractable sum or integral, such as the gradient of the log partition function of an undirected model.

Monte Carlo Sampling: Basics

- Monte Carlo sampling can be used, when a sum or an integral cannot be computed exactly,
- Approximate the expectation by a corresponding average
 - By viewing a sum or integral as if it was an expectation under some distribution

$$s = \sum_{\mathbf{x}} p(\mathbf{x}) f(\mathbf{x}) = E_p[f(\mathbf{x})]$$

$$s = \int p(\mathbf{x})f(\mathbf{x})d\mathbf{x} = E_p[f(\mathbf{x})]$$

Monte Carlo Sampling: Basics

• Approximate $oldsymbol{s}$ by drawing n samples $oldsymbol{x}^{(1)},\ldots,oldsymbol{x}^{(n)}$

$$\hat{s}_n = rac{1}{n} \sum_{i=1}^n f(m{x}^{(i)})$$
 According to the law of large numbers, when the samples $m{x}^{(i)}$ are i.i.d.,

the estimator 's is unbiased

$$\mathbb{E}[\hat{s}_n] = \frac{1}{n} \sum_{i=1}^n \mathbb{E}[f(\boldsymbol{x}^{(i)})] = \frac{1}{n} \sum_{i=1}^n s = s \qquad \lim_{n \to \infty} \hat{s}_n = s$$

The variance $Var[\hat{s}n]$ decreases and converges to 0, so long as $Var[f(x(i))] < \infty$:

$$\operatorname{Var}[\hat{s}_n] = \frac{1}{n^2} \sum_{i=1}^n \operatorname{Var}[f(\mathbf{x})]$$
$$= \frac{\operatorname{Var}[f(\mathbf{x})]}{n}$$

Importance Sampling

• Sample from q and average pf/q

$$p(\mathbf{x})f(\mathbf{x}) = q(\mathbf{x})\frac{p(\mathbf{x})f(\mathbf{x})}{q(\mathbf{x})}$$

The optimal choice q* is obtained by minimizing variance

$$q^*(\boldsymbol{x}) = \frac{p(\boldsymbol{x})|f(\boldsymbol{x})|}{Z}$$

Importance Sampling

$$q^*(\boldsymbol{x}) = \frac{p(\boldsymbol{x})|f(\boldsymbol{x})|}{Z}$$

$$\hat{s}_p = \frac{1}{n} \sum_{i=1,\mathbf{x}^{(i)} \sim p}^{n} f(\mathbf{x}^{(i)})$$

$$\hat{s}_q = \frac{1}{n} \sum_{i=1,\mathbf{x}^{(i)} \sim q}^{n} \frac{p(\mathbf{x}^{(i)}) f(\mathbf{x}^{(i)})}{q(\mathbf{x}^{(i)})}$$

$$\mathbb{E}_q[\hat{s}_q] = \mathbb{E}_q[\hat{s}_p] = s$$

$$\operatorname{Var}[\hat{s}_q] = \operatorname{Var}[\frac{p(\mathbf{x})f(\mathbf{x})}{q(\mathbf{x})}]/n$$

Biased Importance Sampling

It does not require normalized p or q.

$$\hat{s}_{BIS} = \frac{\sum_{i=1}^{n} \frac{p(\boldsymbol{x}^{(i)})}{q(\boldsymbol{x}^{(i)})} f(\boldsymbol{x}^{(i)})}{\sum_{i=1}^{n} \frac{p(\boldsymbol{x}^{(i)})}{q(\boldsymbol{x}^{(i)})}}$$

$$= \frac{\sum_{i=1}^{n} \frac{p(\boldsymbol{x}^{(i)})}{\tilde{q}(\boldsymbol{x}^{(i)})} f(\boldsymbol{x}^{(i)})}{\sum_{i=1}^{n} \frac{p(\boldsymbol{x}^{(i)})}{\tilde{q}(\boldsymbol{x}^{(i)})}}$$

$$= \frac{\sum_{i=1}^{n} \frac{\tilde{p}(\boldsymbol{x}^{(i)})}{\tilde{q}(\boldsymbol{x}^{(i)})} f(\boldsymbol{x}^{(i)})}{\sum_{i=1}^{n} \frac{\tilde{p}(\boldsymbol{x}^{(i)})}{\tilde{q}(\boldsymbol{x}^{(i)})}}$$

Biased, but asymptotically unbiased

Markov Chain Monte Carlo Methods

- Use Markov chains to perform Monte Carlo estimates
- Applicable when the model does not assign zero probability to any state
 - Energy-based model (EBM)
- Sampling from an EBM
 - Ancestral sampling
 - When graph is directed and acyclic
 - Generally, chicken-and-egg problem on P(a,b)
 - Draw a from P(a|b) and draw b from P(b|a)
 - → Sampling using a Markov chain

- Markov chain
 - Defined by a random state x and a transition distribution $T(x' \mid x)$
 - Running the Markov chain
 - Repeatedly updating the state x to a value x' sampled from $T(x' \mid x)$
- Running Markov chains in parallel
 - $-q^{(0)}$: initial distribution
 - $-q^{(t)}(x') = \sum_{x} q^{(t)}(x)T(x'|x)$
 - $-q^{(t)}(x) \to p(x)$

Countable cases

$$-q(x = i) = v_i \implies q \text{ as } v$$

$$-A_{i,j} = T(x' = i | x = j) \text{: Stochastic matrix}$$

$$-v^{(t)} = Av^{(t-1)} \implies v^{(t)} = A^t v^{(0)}$$

- Perron-Frobenius theorem
 - If there is a non-zero probability of transitioning from any state x to any other state x' for some power t, the largest eigenvalue is real and equal to 1.

$$\boldsymbol{v}^{(t)} = \left(\boldsymbol{V} \operatorname{diag}(\boldsymbol{\lambda}) \boldsymbol{V}^{-1} \right)^t \boldsymbol{v}^{(0)} = \boldsymbol{V} \operatorname{diag}(\boldsymbol{\lambda})^t \boldsymbol{V}^{-1} \boldsymbol{v}^{(0)}$$

all of the eigenvalues that are not equal to 1 to decay to zero

Perron-Frobenius theorem

- $[A]: J \times J$ matrix
- π is **left eigenvector** with **eigenvalue** λ if $\pi \neq 0$ and

$$\pi[A] = \lambda \pi$$

• ν is **right eigenvector** with **eigenvalue** λ if $\pi \neq 0$ and

$$[A]\nu = \lambda\nu$$

• Eigenvectors with eigenvalue λ exist if $[A - \lambda I]$ is singular, *i.e.*

$$\det([A - \lambda I]) = 0$$

Perron-Frobenius theorem

- $x = (x_1, ... x_J)$ is **positive** (x > 0) if $x_j > 0$, j = 1, ..., J
- $[A] = [A_{ij}]$ is **positive** ([A] > 0) if $A_{ij} > 0$, i, j = 1, ..., J
- $x = (x_1, ... x_J)$ is non-negative: $x \ge 0$
- [A] is non-negative: $[A] \ge 0$
- x > y if (x y) > 0
- A $J \times J$ matrix [A] is **irreducible** if $[A] \ge 0$ and $\sum_{n=1}^{J-1} [A]^n > 0$ (single recurrent class)

Perron-Frobenius theorem

- Corollary 6: Let λ be the largest eigenvalue of a **positive** $\mathbf{matrix} [A] > 0$ and let $\pi (\nu)$ be the positive left (right) eigenvector of λ normalized such that $\pi \nu = 1$, then $\lim_{n \to \infty} \frac{[A]^n}{\lambda^n} = \nu \pi$
- Theorem 6: Let [P] be the transition matrix of an *ergodic* Markov chain. Then λ = 1 is the largest real eigenvalue of of
 [P], and λ ≥ |λ'| for every other eigenvalue λ'. Furthermore,

we have
$$\lim_{n\to\infty}\frac{[P]^n}{\lambda^n}=e\pi=\left[\begin{array}{ccc}\pi_1&\cdots&\pi_J\\ \vdots&&\vdots\\ \pi_1&\cdots&\pi_J\end{array}\right]$$

 Theorem 6 can be extended to Markov chains with a single ergodic class and transients.

- A is guaranteed to have only one eigenvector with eigenvalue 1 for ergodic Markov chain
- Perron-Frobenius theorem

$$-\lim_{t\to\infty} \mathbf{A}^t = \boldsymbol{\pi} \mathbf{e}^T$$

- Running Markov Chain converges to stationary distribution
 - Equilibrium distribution: π

$$-\lim_{t\to\infty} A^t \boldsymbol{v}^{(0)} = \boldsymbol{\pi} \boldsymbol{e}^T \, \boldsymbol{v}^{(0)} = \boldsymbol{\pi}$$

Harris chain: the Markov chain for continuous variables


$$q'(\mathbf{x}') = \mathbb{E}_{\mathbf{x} \sim q} T(\mathbf{x}' \mid \mathbf{x})$$


- Burning in the Markov chain
 - Running the Markov chain until it reaches its equilibrium distribution
- Mixing time
 - The number of steps for running the Markov chain before reaching its equilibrium distribution.


Gibbs Sampling

- $T(x' \mid x)$: which one is appropriate?
- Gibbs sampling
 - sampling from T(x'|x) is accomplished by selecting one variable x_i and sampling it from p_{model} conditioned on its neighbors in the undirected graph G defining the structure of the energy-based model
- Block Gibbs sampling
 - Gibbs sampling approaches that update many variables simultaneously
 - E.g.) visible and hidden variables in RBM


The Challenge of Mixing between Separated Modes

An illustration of the slow mixing problem in deep probabilistic models

Tempering to Mix between Modes

• Augment energy-based with an extra parameter β

$$p_{\beta}(\boldsymbol{x}) \propto \exp\left(-\beta E(\boldsymbol{x})\right)$$

the reciprocal of the temperature

• Tempering: a general strategy of mixing between modes of p_1 rapidly by drawing samples with $\beta < 1$.
