

Learning and Approximation

- How well will our trained neural network do on new data?
- We minimize the *empirical risk*: $\widehat{\mathcal{R}}(\theta) = \frac{1}{N} \mathcal{L}(f_{\theta}(\mathbf{x}^{(i)}), \mathbf{y}^{(i)})$
- We actually want the population risk (test error) to be small:

$$\mathcal{R}(\theta) = \mathbb{E}_{(\mathbf{x}, \mathbf{y}) \sim \mathcal{P}} \mathcal{L}(f_{\theta}(\mathbf{x}), \mathbf{y})$$

Learning and Approximation

- How well will our trained neural network do on new data?
- We minimize the *empirical risk*: $\widehat{\mathcal{R}}(\theta) = \frac{1}{N} \mathcal{L}(f_{\theta}(\mathbf{x}^{(i)}), \mathbf{y}^{(i)})$
- We actually want the population risk (test error) to be small:

$$\mathcal{R}(\theta) = \mathbb{E}_{(\mathbf{x}, \mathbf{y}) \sim \mathcal{P}} \mathcal{L}(f_{\theta}(\mathbf{x}), \mathbf{y})$$

Important questions:


Approximation: what is the best $\widehat{\mathcal{R}}(\theta^*)$ we can achieve with our model?

Optimization: how well are we minimizing $\widehat{\mathcal{R}}(\theta)$?

Generalization: how different is $\widehat{\mathcal{R}}(\theta)$ from $\mathcal{R}(\theta)$?





Answer: Everything (that is continuous)

• Weaker: average error $||f - g||_1 = \int_0^1 |f(\mathbf{x}) - g(\mathbf{x})| < \epsilon$

Making things formal

• "Universal Approximation": for any continuous function $g(\mathbf{x})$ and any error ϵ there exists a neural network $f(\mathbf{x})$ such that for any $\mathbf{x} \in [0,1]^d$: $|f(\mathbf{x}) - g(\mathbf{x})| < \epsilon$

• Weaker: average error
$$||f - g||_1 = \int_0^1 |f(\mathbf{x}) - g(\mathbf{x})| < \epsilon$$

• We often approximate functions via linear combinations of "basis" functions... m

$$f(\mathbf{x}) = \sum_{j=1}^{\infty} \alpha_j \phi_j(\mathbf{x})$$

Formal result

• What functions can a neural network approximate (by setting its parameters to arbitrary values)?

we will prove this:


Theorem: Let g be an arbitrary L-Lipschitz function and $\epsilon > 0$ be given. Then there exists a 3-layer ReLU network f with $\Omega([L/\epsilon]^d)$ units such that

$$\int_{[0,1]^d} |f(x) - g(x)| \, dx \le 2\epsilon.$$

Step 1: approximate g(x) with indicator functions







Side remark: Lipschitz functions

Function g(x) is L-Lipschitz if

$$|g(\mathbf{x}) - g(\mathbf{x}')| \le L||\mathbf{x} - \mathbf{x}'||$$










3-Layer ReLU network



Layer 2 and 3 are both strictly linear, hence can collpase into a single linear layer, hence: a 2-layer ReLU net can approx any continuous univariate function arbitrarily well.

Theorem (Barron): For
$$g: \mathbb{R}^d \to \mathbb{R}$$
, there exists a 2-layer neural network with k hidden units such that $\int_0^1 |f(x) - g(x)|^2 dx \le 4C_f/k$ where $C_f = \|\widehat{\nabla f}\|_1^2 = (\int \|w\| |\widehat{f}(w)| dw)^2$






ReLUs can potentially split each linear piece.


If the input has N such pieces, the output can have up to 2N.


Each additional layer in depth can double the number of linear pieces.






Depth vs width: summary

Number of linear pieces increases up to exponentially in depth, but only up to linearly in width:

$$\kappa(f(x)) \leq (2n)^L \qquad \text{width}$$



What are the implications for approximating wiggly functions?


Theorem (*Telgarsky 2015,2016*): For any L > 1 there exists a function g(x) such that g(x) can be expressed by a (deep) ReLU network with $3L^2 + 6$ units and $2L^2 + 4$ layers, but any (shallow) ReLU network with L layers and $\leq 2^L$ nodes cannot approximate it to error $||f - g||_1 < 1/32$.


Note: You can approximate it with a 2-layer network, but need exponentially more units


$$g(x) = \text{relu}(2\text{relu}(x) - 4\text{relu}(x - \frac{1}{2}))$$






Depth separation: more examples

• Indicator of the unit ball in \mathbb{R}^d can be approximated to accuracy ϵ using a 3-layer ReLU net with $O(d/\epsilon)$ neurons. But it cannot be approximated to an accuracy higher than $O(1/d^4)$ using a 2-layer network, unless its width is exponential in d.

$$g(x) = \mathbf{1}[||x|| \le 1]$$

Depth separation: more examples

• Indicator of the unit ball in \mathbb{R}^d can be approximated to accuracy ϵ using a 3-layer ReLU net with $O(d^2/\epsilon)$ neurons. But it cannot be approximated to an accuracy higher than $O(1/d^4)$ using a 2-layer network, unless its width is exponential in d.

• Several nonlinear and twice-differentiable functions (including $x \mapsto x^2$) can be approximated to accuracy ϵ using ReLU networks of depth and width $O(\text{poly}(\log(1/\epsilon)))$, but cannot be approximated to similar accuracy by constant-depth ReLU networks, unless their width is at least $\Omega(\text{poly}(1/\epsilon))$.

Answer: there is an optimal "aspect ratio" (width/depth), which varies for different problems. But large range of aspect ratios are acceptable. Depth and width should be roughly similar: if you scale one, scale the other too.


Preview: better architectures can approximate important function classes more efficiently.

• ResNet: 1-unit width is enough (Lin & Jegelka 2018)







- Tells us fundamental limitations, with practical implications
- In practice, can seemingly do with much smaller networks...
- Shallow networks cannot easily approximate deep networks (efficiency)
- Building blocks for understanding approximation with other architectures
